This Region

1. The field is hereby informed on the approval of the issuance of Government Permit to Operate and Certificate of Compliance for School Year 2019-2020 in the divisions of Agusan del Sur, Butuan City, Surigao City, Surigao del Norte and Tandag City offering basic education program.
2. Private school principal/administrator is advised to display the aforementioned government permit to operate in conspicuous places of the school.
3. Government permit which is temporary in nature should be renewed on or before **August 30 of every year** preceding the start of the school year when the school/new course is supposed to operate. On the other hand, government recognition for each year level or course shall be for an indefinite period provided that the requirements of law, rules and standards will be satisfied. (*D.O No. 88, s. 2010, Section 29-30*)
