1. To strengthen the implementation of the various DepEd issuances on Child Protection, such as DepEd Order No. 40, s. 2012 (DepEd Child Protection Policy), DepEd Order No. 55, s. 2013 (Implementing Rules and Regulations of the Anti-Bullying Act of 2013) and DepEd Order No. 18, s. 2015 (DepEd Guidelines and Procedures on the Management of Children-At-Risk (CAR) and Children in Conflict with the Law (CICL), the Office of

the Undersecretary for Legal Affairs will be conducting the National Training for Child Protection Specialists (CPS) – Level II.

2. The National Training for CPS aims to equip the participants with the knowledge, skills, and attitudes to provide the necessary assistance in the schools within the CPS's respective Regions and Divisions. Upon completion of the training, it is expected that the CPS will be able to efficiently assist and ensure school compliance of all the requirements laid by the aforementioned DepEd issuances and other laws related to Child Protection.
3. The National Training is scheduled on **20-23 March 2018** in Chali Beach Resort and Conference Center, Zone 3, Cagayan de Oro City.
4. The list of selected participants for the National Training is attached as Annex A of this Memorandum. For your guidance, the Administrative Notes and Program of Activities are attached as Annex B and C, respectively.

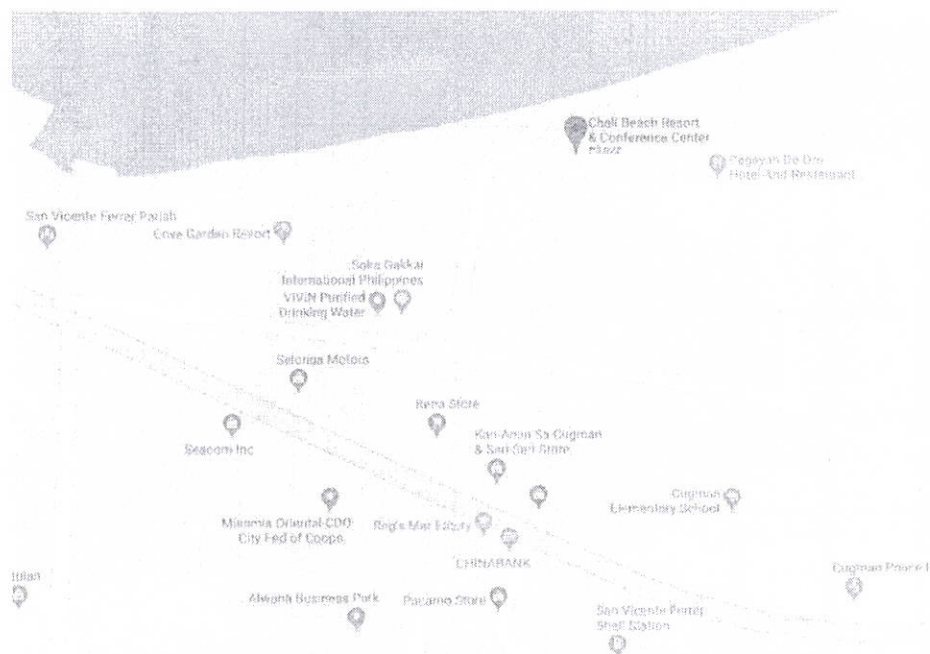
