**ANNOUNCEMENT ON THE ISSUANCE OF GOVERNMENT PERMIT TO OPERATE/GOVERNMENT  
RECOGNITION TO PRIVATE SCHOOLS FOR SY 2019-2020**

**TO: Schools Division Superintendents**  
Private School Coordinators  
School Administrators/Principals  
This Region

1. The field is hereby informed on the approval of the issuance of Government Permit to Operate and Certificate of Compliance for School Year 2019-2020 in the divisions of Cabadbaran City and Surigao del Norte offering basic education program.
2. Private school principal/administrator is advised to display the aforementioned government permit to operate in conspicuous places of the school.
3. Government permit which is temporary in nature should be renewed on or before **August 30 of every year** preceding the start of the school year when the school/new course is supposed to operate. On the other hand, government recognition for each year level or course shall be for an indefinite period provided that the requirements of law, rules and standards will be satisfied. (D.O No. 88, s. 2010, Section 29-30)
