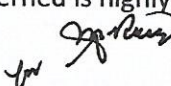

4. Traveling expenses and per diem of teacher-participants, training management team, process observers, training facilitators, secretariat, QATAME In-charge and nurse shall be charged against School MOOE/Local Funds subject to the usual accounting and auditing rules and regulations.
5. The participants, secretariat and training facilitators shall be entitled to five (5) days service credits in accordance with DepEd Order No. 53, s. 2003 entitled Updated Guidelines on the Grant of Vacation Service Credits to Teachers. On the other hand, non-teaching personnel shall be provided with three (3) days Compensatory Time-Off (CTO) per Civil Service Commission (CSC), and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration of Overtime Service Rendered.
6. All other provisions stipulated in the Regional Memorandum No. 215, s. 2019 are still in effect.
