**CORRIGENDUM OF REGIONAL MEMORANDUM NO. 251, S. 2019 RE: CALL FOR NOMINEES FOR
BULAWANONG SULÔ AWARDS 2019**

1. Please be informed of the exclusion of a criterion Networking/Linkages in some award categories reflected in *Annex C: Criteria for the Bulawanong Sulô Awards/Bulawanong Pasidungog* of Regional Order No. 24, s. 2019 on the Revised Policy Manual on Rewards and Recognition System of DepEd Caraga - enclosure of Regional Memorandum No. 251, s. 2019 re: Call for Nominees for *Bulawanong Sulô Awards 2019*, per instruction of the Civil Service Commission - Caraga Region through a letter dated June 25, 2019.

2. Exclusion of Networking/Linkages criterion is deemed necessary as it does not comply with the provisions of *Section I, item (f), Rule X Grounds for Administrative Disciplinary Action of RA 6173*, to wit:

"Soliciting or accepting, directly or indirectly, any gift, gratuity, favor, entertainment, loan or anything of monetary value which in the course of his official duties or in connection with any operation being regulated by, or any transaction which may be affected by the functions of, his office. The propriety or impropriety of the foregoing shall be determined by its value, kinship or relationship between giver and receiver and the motivation. A thing of monetary value is one which is evidently or manifestly excessive by its very nature."

3. For the Criteria on Outstanding Teacher and Master Teacher, indicator number 3 on Community Development shall exclude Networking/Linkages and shall only include Outreach Activity for ten (10) points with the following rubric:

4. For Outstanding ALS Mobile Teacher, under item 1. Occupational Competence, 1.1.2 Source-Out funds from NGOs, LGUs and other organizations shall be excluded. 1.1.4 Published articles on ALS programs/projects shall be given ten (10) points. 1.1.5 Served as Resource Person/trainer/facilitator shall also be given ten (10) points. The following rubric shall be used for both indicators.

Item number 2 on Professional Competence shall be given fifty-five (55) points instead of forty-five (45) points. Specifically, 2.2 Research and creative outputs, re-entry projects after attendance to seminars shall be given ten (10) points; and 2.4 Published supplementary materials, articles, references and other papers shall be given ten (10) points, with the following rubric.

For Outstanding Public Schools District Supervisor, Education Program Supervisor (SDO and RO levels) in item number 4 on Community Development, 4.2 Networking/Linkages shall be excluded and only 4.1 Outreach Program shall be considered which shall be given ten (10) points with the following rubric.
