1. This is to inform the field on the approval of the applications of DepEd/Non-DepEd Schools implementation of the Senior High School (SHS) Program. The approval to operate and government permit to operate issued to qualified schools shall be subject to revocation anytime the school fails to maintain the standards required for the program.
2. The approval to operate for DepEd/Non-DepEd Schools are subject to the provisions of DepEd Order No. 51, s. 2015, DepEd Order No. 26, s. 2017, and DepEd Memorandum No. 004, s. 2014.
3. The School Principals/Administrators are advised to display the approval to operate in conspicuous places of their school.
4. The additional program for DepEd/Non-DepEd Schools is governed by DepEd Memorandum No. 004, s. 2014 and RM # 236, s. 2017 that ***"DepEd Schools who are interested to offer SHS Program may express their intent through the submission of all requirements on AUGUST 30 of the year preceding the school year of their intended operation."***
5. The DepEd Schools Approval to Operate original copy shall be secured by the Division SHS Coordinator or School Heads at RO QAD.
