**SEMINAR-WORKSHOP OF SECONDARY SCHOOL PRINCIPALS ON RA 9165-
"The Comprehensive Dangerous Drugs Act of 2002"**

TO: **Schools Division Superintendents**
This Region

1. The National Drug Education Program (NDEP) is a whole-year activity of the Department of Education that is implemented and institutionalized in all schools nationwide. It is an educational endeavour that aims to raise the consciousness of the students on the perils of the use of illicit drugs. Hence, a 4-day Seminar Workshop of Secondary Principals on RA 9165 "The Comprehensive Dangerous Drugs Act of 2002" which strengthened the legal responsibility of the School Administrators in formulating educational programs and strengthen the school-based drug abuse prevention interventions in schools pursuant to Article IV of RA 9165 will be conducted on October 22-25, 2019 at a venue to be announced later.
2. The objectives of the orientation-workshop are to:
 - a. orient the participants on the nature and ill-effects of drug abuse and on the provisions of Article IV of RA 9165;
 - b. explain the responsibilities of the school heads on drug abuse prevention in schools;
 - c. Discuss the integration of National Drug Education Program in School-Based Management and School Improvement Plan;
 - d. formulate action plans for the effective interventions to prevent drug abuse in schools.
3. Each Schools Division Offices must send 5 (five) selected Secondary School Principals as participants on the aforementioned Seminar-Workshop. Please submit the list of confirmed participants on or before October 11, 2019 using the attached template.
4. Participants are expected to be at the training venue on Day One (October 22) at 1:00 pm for registration. The training shall start promptly at 2:00 PM. Check-out shall be at 12:00 noon of Day Four (October 25). Meals shall be provided to all participants for duration of the training, from lunch on Day One to the Breakfast on the Day Four.
