THE 2018 REGIONAL SCIENCE FAIR AND QUIZ PLUS (RSFQP)**

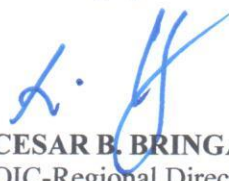
