**TWO-DAY SESSION/CONSULTATION WITH THE REGIONAL/DIVISION LEVEL
CONSULTATIVE AND ADVISORY BODIES (CABs) ON IPED PROGRAM
IMPLEMENTATION**

To: Schools Division Superintendents
This Region

1. A Two-day Session/Consultation with the Regional/Division Level Consultative and Advisory Bodies (CABs) on IPED Program Implementation shall be held on November 28-29, 2018 at New Rosario Food Corporation, Butuan City.
2. The activity aims to:
 - provide an opportunity for IP elders for consensus building on key concepts, processes, mechanisms and procedures vital to the current developments in IPED; and
 - be an avenue for continuing dialogue of IP communities with DepEd.
3. Participants to the said activity are the RO/DO IPED focal persons, alternate focal persons, and the Regional/Division Level CABs/IP community resource persons. The list of expected participants and the activity matrix are found in the enclosures for your reference.
4. Meals and accommodation of participants shall be charged against the Regional IPED PSF for FY 2018 while their travel expenses shall be charged against the Division IPED PSF and/or local funds subject to the usual accounting and auditing rules and regulations. First meal shall be breakfast on November 28, 2019 and last meal shall be dinner on November 29, 2018.
5. The honoraria of all attending IP community resource persons shall be charged against the Regional IPED PSF subject to the usual accounting and auditing rules and regulations.

The provision of honoraria shall be based on the Unnumbered DepEd Memorandum dated June 5, 2017 (Provision of Honoraria to IP Community Resource Persons and Payment of Travel Expenses of IP Community Representatives Invited to IPED Program Activities).
6. Immediate dissemination of this Memorandum to all concerned is highly desired.
