Speakers Bureau Training On Capability Building for Division NDEP Coordinator in Drug Abuse Prevention and Control

1. The **Philippine Drug Enforcement Agency (PDEA)** of Caraga Region shall conduct a Three-Day Speakers Bureau Training On Capability Building for Division National Drug Education Program (NDEP) Coordinator in Drug Abuse Prevention and Control and other related activities for DepED personnel. It shall be held at Denaville Resort, Brgy. Alegria, Santa Monica, Siargao, Surigao del Norte on November 27 to December 1, 2018.

The Seminar-Workshop sponsored by **PDEA** provides an overview of the quality Improvement and development of instructional methods and training on leadership, effective parenting and curriculum integration.

2. The Seminar-Workshop aims to:

- discuss the core messages which identified and incorporated according to the specific levels;
- explain and identify the gap
 - The who, what, when, and how to implement the laws penalizing drug use and trafficking;
 - The influence of personal and environmental factors on vulnerability and risk;
 - Human development both for targeting interventions, but also for tailoring messaging and intervention strategies;
- describe the background and principles underlying the development of the tools and guidelines in order to help young people enhance their life skills which relate to the prevalence of drug abuse;
- to monitor, assess and describe the importance of implementation in order to strengthen NDEP as one components of the six flagship of Ok sa DepEd;
- formulate action plans for the implementation of evidence-based NDEP as flagship of Ok sa DepEd; and
- Provide NDEP coordinators with knowledge about the most effective evidence-based policy implementation programs.
