1. The Bureau of Learning Delivery – Student Inclusion Division (BLD-SID) will conduct the **Madrasah Education Program Annual Conference** on **January 8-12, 2019 (inclusive of travel time) at Zamboanga del Norte** (exact venue to be announced later).
