Government permit which is provisional in nature should be renewed on or before August 30 of every year preceding the start of the school year when the school is supposed to operate and the school head is advised to comply with the basic requirements stipulated in Part VI, items A.2 and B.2 of DepED Order No. 40, s. 2014. Moreover, the concerned schools will be subject for re-ocular inspection by the Regional Inspectorate Team. On the other hand, schools with permanent government permit shall be for an indefinite period provided that the requirements of law, rules and standards will be satisfied.

4. The Planning Officer of the Schools Division Office shall be given a copy of this Permit to Operate for records updating of the said school. Should there be inconsistencies of the name of the school indicated in the Permit issued against what is reflected in the General Appropriations Act (GAA), the school head/Planning Officer must confer the same with the Schools Division Superintendent for appropriate action.
