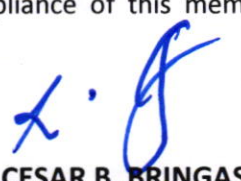

8. Participants shall be entitled of Compensatory Time-Off (CTO) and Service Credits, whichever is applicable, to compensate services rendered during holidays, weekends, and summer vacation.
9. Travel, board and lodging, and other incidental expenses of participants shall be charged against BLR funds downloaded to the region/divisions, subject to the usual accounting and auditing rules. Participants are required to submit their travel authority to the activity secretariat for activity liquidation purposes.
