REMINDER FOR LUNDUYAN COHORT 2 NON-COMPLETERS AND OTHER
RELEVANT INFORMATION ON THE IMPLEMENTATION
OF LUNDUYAN SA KAHUSAYAN

1. The National Educators Academy of the Philippines (NEAP) in collaboration with National Teachers College (NTC) has implemented the Lunduyan sa Kahusayan training program for Cohort 2 participants from July 04 to August 19, 2022.
2. NEAP and NTC however noticed some teacher-scholars failed to complete their respective training courses. The concerned teacher-scholars are reminded that DM 82 s. 2020 (Guidelines on the Registration of Teachers and School Leaders for NEAP – Recognized Professional Development Programs and Courses) and in the scholar's NEAP PDP contract that scholars are expected to *maintain the academic standards and other course requirements set for by the program. Otherwise, the scholars need to refund in full to the DepEd such sum of money as may have been defrayed by the Philippine government for expenses incidental for having attended the program or course, for failure to comply with any of the foregoing conditions.*
3. An initial communication was sent to non-completers encouraging them to join the Cohort 3. Those have not signified their intention to complete the training program are advised to join the upcoming Cohort 4 training program.
4. The activity aims to:
 - a. provide chance to all the cohort 2 non-completers to finish their training program in Lunduyan sa Kahusayan; and
 - b. keep away the non-completer PD participants from the burden of refunding the DepEd the amount of the training program.
