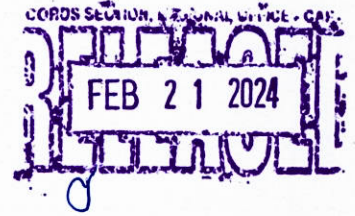

SUBMISSION OF DATA ON SELF-LEARNING MODULES (SLM) NEEDS

- Pursuant to the National Expenditure Program (NEP) 2024 financial allocation to DepEd Caraga amounting to PhP 80,751,112 and to ensure the timely availability of the required printed Self-Learning Modules (SLMs) and other LR needs for SY 2024, the Schools Division Offices (SDOs) through the Learning Resource Management Section (LRMS) shall be required to submit a priority list of Self-Learning Modules for procurement in the Regional Office.
- Each SDO is required to submit an inventory of SLMs using the LR Situation Report and the Learning Resource Needs Report (LRNR) templates on this link https://bit.ly/LR-SitRep_LR-NeedsRep. It is also required that SDOs shall send scanned copy of the duly accomplished reports to caragalr@deped.gov.ph on or before March 15, 2024.
- In identifying the SLM needs, SDOs shall maintain at least one SLM for two (2) learners (1:2) ratio. They are likewise reminded to limit their list of needs according to the indicative allocation per division below:
