3. The Content Specialist shall have the following functions:

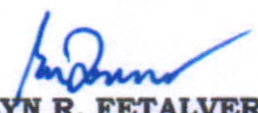
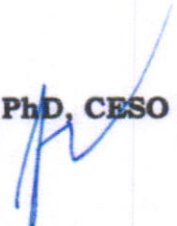
- 3.1 review program/course proposals based on the alignment of the criteria set in DO 001, s. 2020.
