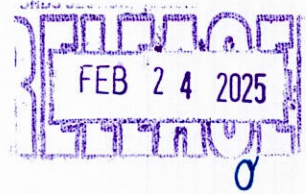

CLASSROOM ASSESSMENT IN LIGHT OF THE MATATAG CURRICULUM

1. The Department of Education-Caraga rationalizes the implementation of DepEd Order No. 08, s. 2015 (*Policy Guidelines on Classroom Assessment for the K to 12 Basic Education Program*) in light of DepEd Order No. 10, s. 2024 (*Policy Guidelines on the Implementation of the MATATAG Curriculum*).

2. In accordance with Table 4 (Weight of the Components for Grades 1–10) of DepEd Order No. 8, s. 2015, the new MATATAG Curriculum subjects shall follow the corresponding graded components as outlined below:

| Components           | Languages <sup>a</sup> | Social Sciences <sup>b</sup> | GMRC/VE | Science | Math | MAPEH | EPP/TLE |
|----------------------|------------------------|------------------------------|---------|---------|------|-------|---------|
| Written Work         |                        | 30%                          |         | 40%     |      | 20%   |         |
| Performance Tasks    |                        | 50%                          |         | 40%     |      | 60%   |         |
| Quarterly Assessment |                        | 20%                          |         | 20%     |      | 20%   |         |

3. All other provisions of the aforementioned policy, including the weight of the graded components for the Senior High School curriculum, remain in effect.
