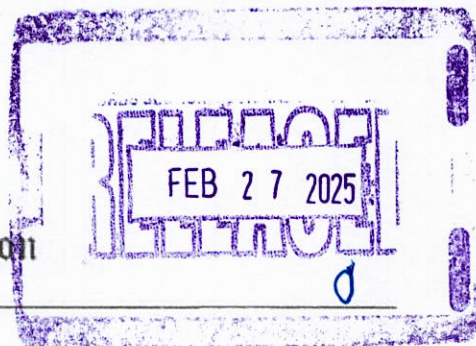

(CPC) FUNCTIONALITY ASSESSMENT TOOL
MONITORING SHEET

1. This has reference to Regional Memorandum No. 1276, s. 2024, regarding the "Child Protection Committee (CPC) Functionality Assessment Tool Monitoring Sheet," dated November 21, 2024.
2. Pursuant to DepEd Order No. 40, s. 2012, all public and private elementary and secondary schools shall establish a **Child Protection Committee (CPC)** to fulfill their roles and responsibilities in safeguarding the rights and protection of all learners.
3. The CPC Functionality Assessment Tool Monitoring Sheet is designed to systematically evaluate and monitor the effectiveness and operational capacity of the Child Protection Committees. By utilizing this tool, committees can ensure that their activities align with established guidelines and standards, enhancing their accountability and impact in promoting children's rights and well-being.
