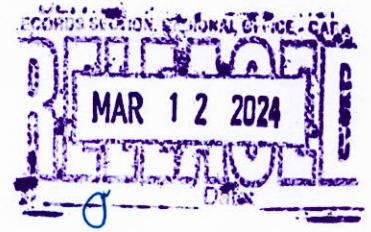

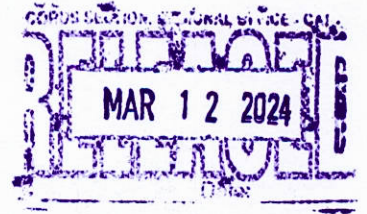

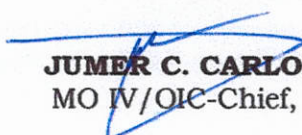

Siargao	120,000.00	720,000.00	Php 840,000.00

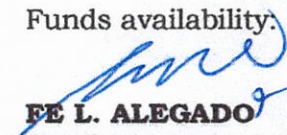
Funds shall be charged against the FY 2023 DPRP Funds with SARO No. OSEC-13-23-4224, subject to the usual accounting and auditing procedures.
