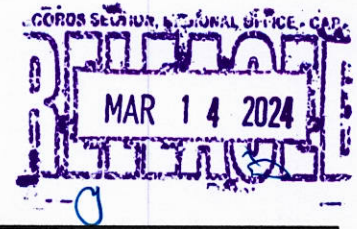

RECONSTITUTION OF THE REGIONAL SCREENING

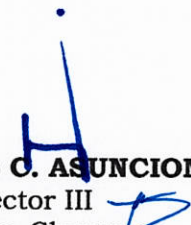
