CORRIGENDUM AND ADDENDUM TO REGIONAL MEMORANDUM NO. 0294, S. 2026, ON THE TRAINING FOR LEARNER RIGHTS AND PROTECTION ADVOCATES IN PREPARATION FOR PALARONG PAMBANSA 2026 CUM LRP SPECIALIZATION COURSE

1. This Office issues the following addendum to Regional Memorandum No. 0294, s. 2026 titled *Training for Learner Rights and Protection (LRP) Advocates in Preparation for Palarong Pambansa 2026, cum LRP Specialization Course* scheduled for April 6-8, 2026:

a. Arrival. To ensure all participants can begin the standardized program on time, participants are encouraged to arrive at the training venue on Day 0 (April 5, 2026).

b. Priority Accommodation. Early check-in accommodations on April 5 are specifically offered to Resource Speakers outside the Caraga Region and participants traveling from distant divisions.

c. Provision. Dinner will be provided on the evening of April 5 for those staying in the venue.

d. Compensatory Time Off (CTO). As April 5 is a Sunday, the arrival date shall be covered by a CTO agreement. A duly signed Daily Time Record (DTR) by the ESSD Chief shall be required to support this provision.
