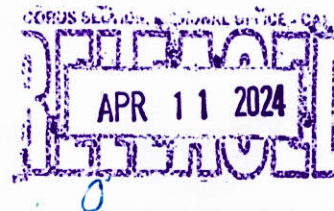

First of all, we would like to express our heartfelt gratitude for your immediate response to our call for a convergence meeting which was held last April 5, 2024, despite the very short notice. This only shows the true essence of collaboration and partnership among various agencies with shared objectives and aspirations to resolve current issues the DENR is currently facing.

We would like to update each member of the convergence team that the Cancellation Order has already been served this morning, April 8, 2024 by the DENR thru the Protected Area Superintendent (PASu) of Siargao Island Protected Landscape and Seascape (SIPLAS) and the Provincial Environment and Natural Resources Officer (PENRO) of Surigao del Norte, without hesitation from Socorro Bayanihan Services, Incorporated (SBSI).

However, there is still a need for us to meet again, per our agreement, on April 12, 2024 at the Surigao del Norte Provincial Governor's Conference Room, Provincial Capitol, Surigao City. This meeting would help the DENR in laying down the details of relocation/reintegration of SBSI members, rehabilitation of the PACBRMA site, and provision of other services by the Provincial/Municipal Local Government Unit, DSWD, DHSUD, and other government agencies.
