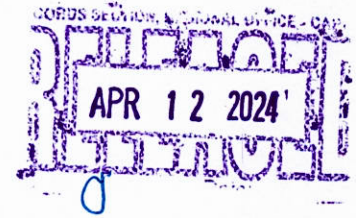

CONDUCT OF THE 2ND REGIONAL CHILD PROTECTION SUMMIT
