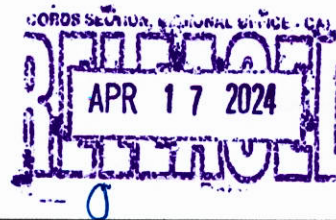

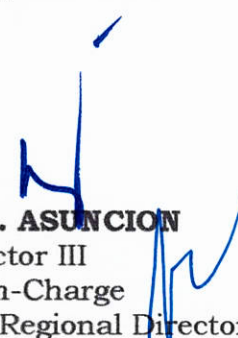

**HRD CONVERGENCE MEETING CUM PROVISION OF TECHNICAL ASSISTANCE
BY THE PROFESSIONAL REGULATION COMMISSION (PRC) ON CONTINUING
PROFESSIONAL DEVELOPMENT (CPD)**

1. Under Republic Act 11713, also referred to as the “Excellence in Teacher Education Act”, Section 18 states that for the continuing professional development of in-service teachers, school leaders, and other teaching-related personnel in all basic education institutions, the NEAP shall (c) coordinate with the PRC for the recognition or accreditation of its programs in compliance with the requirements for continuing professional development.
2. In adherence to the Act, DepEd Central Office issued DM-OUHROD-2024-0410 re: Application of Schools Division Offices as Professional Regulation Commission – Accredited Continuing Professional Development Providers. Along this vein, HRD Convergence Meeting Cum Provision of Technical Assistance by The Professional Regulation Commission on Continuing Professional Development shall be conducted on April 22, 2024, 8:00 AM-5:00 PM at Silver Hall, DepEd Caraga Regional Office.
2. The activity aims to:
 - a. provide technical assistance to Schools Division Offices in the preparation of documentary requirements as CPD Provider;
 - b. discuss PRC policies regarding the Appointment-Based Transactions; and
 - c. enhance understanding, streamline processes, and strengthen partnerships in advancing the CPD framework within the education sector.
3. Participants in this activity are the select PRC Butuan Personnel, CPD Focal Person, HR representative of Recruitment, Selection and Placement (RSP) in each SDO, RO-QATAME In-charge, and all HRDD-NEAP Personnel.
4. Participants shall be accommodated in NEAP Caraga Dormitory Rooms starting April 21, 2024, at 2:00 PM.

5. All expenses for venue, meals, materials, and accommodation incurred during the conduct of the activity shall be charged against the 2023 HRTD Continuing Funds while travel expenses of participants shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
