AMENDMENT TO REGIONAL MEMORANDUM NO. 0200, S. 2026 RE: PERSONNEL
SUPPORT FOR LIVESTREAMING AND NEWSWRITING OPERATIONS
OF THE 2026 PALARONG PAMBANSA

1. In view of the ongoing preparations for the Palarong Pambansa 2026, this issuance amends Regional Memorandum No. 0200, s. 2026 regarding the **assignment** of personnel for **livestreaming** and **newswriting** operations across designated playing venues.

2. This aims to rationalize the deployment of personnel and implement austerity measures, thereby reducing costs related to transportation, accommodation, and other incidental expenses, while still ensuring effective communications and uninterrupted livestreaming coverage.

3. In view of this, the Schools Divisions of Agusan del Sur and Bayugan City are authorized to assign **one livestream assistant** and **one journalist** for **each playing venue**, particularly those residing **proximate** to the playing venues, in **Bayugan City, San Francisco, Esperanza, Talacogon, Bunawan, and Rosario**.

4. Item 1 of the previous memorandum is amended as follows:

A. **Livestream Assistants and Journalists** for venues **outside** the Datu Lipus Makapandong Governor D.O. Plaza Sports Complex.
