CONDUCT OF QUARTERLY BUDGET ACCOUNTABILITY REPORT (BAR) 1
WITH THE SCHOOLS DIVISION OFFICES (SDOs)

1. In DepEd Order No. 029, s. 2022, the Regional M & E system shall ensure the effective, efficient, and inclusive implementation of all education policies and programs and the achievement of desired outcomes. Thus, the Regional M & E System shall strengthen vertical integration to link M & E systems between region and school division offices.
