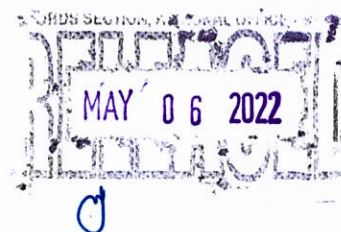

**3RD COORDINATION MEETING FOR THE 2021 NATIONAL QUALIFYING
EXAMINATION FOR SCHOOL HEADS**
