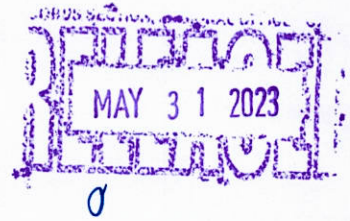

HYBRID PEER MEDIATION TRAINING

1. In keeping with RM 0656 s. 2022 re Pilot Implementation of Peer Mediation Program: Peers Engaged in Addressing Conflicts Effectively (P.E.A.C.E) and RM 0719 s. 2022 re Orientation and Virtual Launching of Peer Mediation Program, DepEd Caraga through the Curriculum and Learning Management Division (CLMD) shall conduct a Hybrid Training on Peer Mediation on July 18-20, 2023 at Butuan Grand Palace Hotel, Butuan City.
2. The training aims to:
 - expand school capacity for peer mediation;
 - harness lessons learned from the pilot training; and
 - mobilize previously trained peer mediators to utilize acquired knowledge and skills.
3. Participants in this hybrid training are Grade 8 learners and teacher-advisers handling Grade 9 classes from the identified pilot school implementers of peer mediation program in SY 2023-2024.
4. The trained peer mediators from Madrid National High School of Surigao del Sur Division shall serve as co-facilitators. They are expected to arrive at the venue with their travel authority on July 17, 2023 for the pre-work activities. Their first meal is breakfast on July 17, 2023 and the last meal is afternoon snacks on July 20, 2023. Free accommodation is provided to the training team from July 17 to 19, 2023.
5. The list of co-facilitators, pilot schools, onsite and online participants as well as the training matrix are found in the Enclosure for your reference.
6. Onsite participants are expected to be at the venue and present their travel authority on July 18, 2023 before 8:00 AM. Their first meal is breakfast on July 18, 2023 and the last meal is afternoon snacks on July 20, 2023 but this is without accommodation.



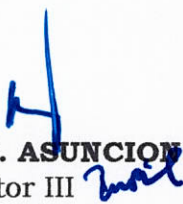

Food for the onsite participants and the training team, accommodation of the resource speaker and co-facilitators, honorarium and travelling expenses of the resource speaker, supplies and materials of the training shall be charged against Regional MOOE 2023 CLMD funds while the travel expenses of co-facilitators shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
8. Online participants are expected to participate via MS Teams platform in their respective schools. The link shall be sent to the email addresses of the identified teacher-advisers.
9. Food, travel expenses and fees incurred for internet connectivity of the online participants shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
10. Participants are required to register through the form embedded in this link: https://bit.ly/HPMT_Registration on or before June 20, 2023.
11. A virtual coordination meeting of the onsite and online participants together with their respective school heads, division Esp supervisors, Youth Formation coordinators and Peace Education coordinators shall be conducted on June 13, 2023 at 10:00 AM in preparation for the said training. The link shall be forwarded to the Esp coordinators' group chat on the day of the meeting.

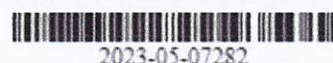

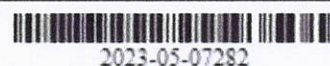
