**WORKSHOP WITH COMMUNITY PARTNERS ON THE TEN-YEAR ASSESSMENT OF
THE INDIGENOUS PEOPLES EDUCATION (IPEd) PROGRAM**

1. The Department of Education Regional Office, through the Curriculum and Learning Management Division (CLMD), shall conduct a Workshop with Community Partners on the Ten-Year Assessment of the Indigenous Peoples Education (IPEd) Program on June 5-6, 2024 at the Copper Hall, DepEd Regional Office, JP Rosales Avenue, Butuan City.
2. The general objective is to provide a venue to consolidate the 10-year assessment reports of the IPEd implementing divisions. It specifically aims to:
