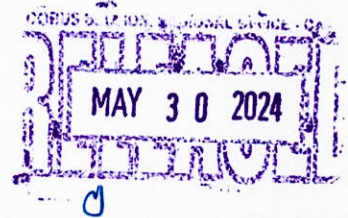

3. In DepEd Memorandum No. 013, s. 2024, item 3, states that the schedule of activities prior to the conduct of the test is as follows:

Participation in this FY 2023 National Qualifying Examination for School Heads (NQESH) shall entitle SDO Evaluators and RO Validators to service credits in accordance with DepEd Order 53 s. 2003 entitled Updated Guidelines on Grant of Vacation Service Credits to Teachers and on the other hand, non-teaching staff shall be provided with Compensatory Time – OFF (CTO) per Civil Service and DBM Circular

No. 2 s. 2004 on Non-Monetary Remuneration for Overtime Services Rendered. Thus, the dates covered for the CTO of the SDO Evaluators and RO Validators are the ff:
