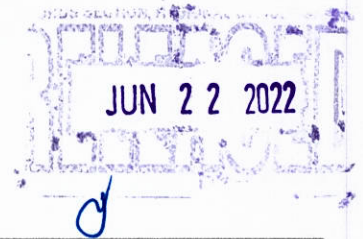

**ANNOUNCEMENT ON THE ISSUANCES OF GOVERNMENT RECOGNITIONS/
GOVERNMENT PERMITS TO OPERATE/ CERTIFICATES OF COMPLIANCE
TO PRIVATE SCHOOLS FOR SY 2022-2023**

1. The field is hereby informed on the approval of the issuances of Government Recognitions/ Permits to Operate and Certificates of Compliance for School Year 2022-2023 in the Divisions of Agusan del Sur, Surigao City, Cabadbaran City and Siargao Islands.
2. Private School Principal/Administrator is advised to display the aforementioned government permit to operate/government recognition/ certificate of compliance permit in conspicuous places of the school.
3. The Government Permit to Operate (GPTO) which is temporary in nature and should be renewed on or before August 30 of every year preceding the start of the school year when the school/new course is supposed to operate. On the other hand, Government Recognition (GR) for each year level or course shall be for an indefinite period provided that the requirements of Rules and Regulations will be satisfied. (D.O. No. 88, s. 2010, Section 29-30).
