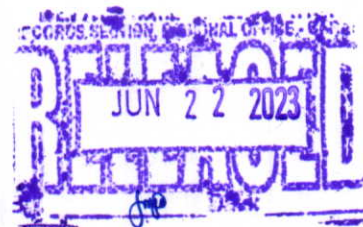

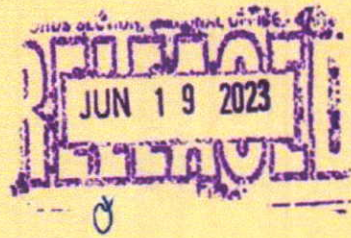

The school authorities shall inform the DepEd of any plan or action regarding closure or phasing out of the program/s or any change/s or deviation/s from the prescribed requirements.

This permit does not extend to any other annex or branch, whether located in the same municipality or city or in other municipalities within the Region.

The foregoing approval to operate is subject to the provisions of DepEd Order No. 51, s. 2015 and DepEd Order No. 26, s. 2017.
