ADDITIONAL GUIDELINES TO THE CONDUCT OF THE NATIONAL
ACHIEVEMENT TEST FOR GRADE 10 LEARNERS FOR
SCHOOL YEAR 2022-2023

1. Relative to Regional Memorandum No. 516, s. 2023 with reference to DepEd Memorandum No. 034, s. 2023 (Administration of the National Achievement Test for Grade 10 for the School Year 2022-2023), the Bureau of Education Assessment (BEA) released DM-CT-2023-171 or the "Additional Guidelines to the Conduct of the National Achievement Test for Grade 10 for School Year 2022-2023.
2. The field is directed to observe the additional guidelines reflected in provisions 1 (Testing Window), 2 (Non-Participating Private Schools), and 3 (Chief Examiner's Transmittal Report Envelope).
3. The Division Testing Coordinators (DTCs) are directed to submit the accomplished "List of Non-Participating Schools in the NATG10 Administration" to the Regional Testing Coordinator (RTC) on or before June 29, 2023 at kevinhope.salvana@deped.gov.ph. The said form downloadable at bit.ly/NATG10OriDrive must reflect the number of non-participating Grade 10 learners from the private schools.
4. DTCs are also directed to submit a justification letter to the RTC for schools administering the NATG10 outside the testing window on or before June 29, 2023 using the same email reflected in the item 3 herein.
