REQUEST FOR INFORMATION OF MEMBERS OF THE CHILD
PROTECTION COMMITTEES (CPC) IN SCHOOLS

1. Pursuant to OUOPS Memorandum No. 2023-07-56 re: Request for Information of Members of the Child Protection Committees in Schools dated June 13, 2023, all public and private elementary and secondary schools shall establish a Child Protection Committee which shall be composed of the following:

- a. School Head/administrator-Chairperson
- b. Guidance Counselor/Advocate-Vice Chairperson
- c. Representative of the Teachers as designated by the Faculty Club
- d. Representative of the Parents as designated by the Parent-Teachers-Association
- e. Representative of pupils, students, and learners as designated by the Supreme Student Council, and
- f. Representative from the Community as designated by the Punong Barangay, preferably a member of the Barangay Council for the Protection of Children (BCPC)

2. SDOs Learner Rights and Protection Office shall take charge of the assessment and functionality of the child protection committees (CPC), concerned data, and monitoring and evaluation of CPCs in schools.

3. All members of the Child Protection Committee (CPC) in schools shall accomplish the CPC Profiling Form through the google drive link: <https://tinyurl.com/2023CPCProfilingForm>, to avoid duplication only the Chairperson or the Vice-Chairperson shall fill out the form. The deadline for the said form is on July 14, 2023.

4. The data submission update shall be utilized by the LRPO for the reinforcement of D.O 40 s., 2012 relative to mandatory establishment of functional CPCs in schools.



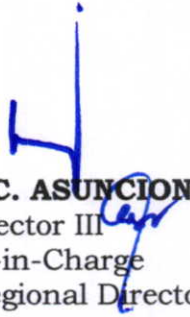
