VIRTUAL REPORTING ON THE IMPLEMENTATION OF 2025 DEPED SUMMER PROGRAM

1. In line with the 2025 DepEd Summer Program, the Department of Education, Caraga Region through the Curriculum and Learning Management Division (CLMD), will conduct a virtual report on the implementation of the Literacy Remediation Program (LRP), Summer Academic Remediation Program (SARP), and National Learning Camp (NLC) on July 2-3, 2025, via MS Teams.
2. This activity aims to evaluate the effectiveness and identify areas for improvement as basis for the literacy intervention under the Academic Recovery and Accessible Learning (ARAL) Program of the region.
3. The participants of this virtual engagement are the CLMD Chief and the Regional Education Program Supervisors, the CID Chiefs and the Division Education Program Supervisors.
4. Each CID Chief will be allotted 20 minutes to present the following:
 - a. analysis of results based on the Post Test for LRP and NLC, and the Recomputed Grades for SARP;
 - b. proposed ways forward and intervention plans; and
 - c. present the funds utilization downloaded to each program.
