REITERATION OF THE VOLUNTARY PARTICIPATION TO THE NATIONAL
LEARNING CAMP AND OTHER END-OF-SCHOOL-YEAR BREAK ACTIVITIES

1. The Department of Education-Caraga Region reiterates the **VOLUNTARY PARTICIPATION** of teachers and learners to the National Learning Camp (NLC) and other End-of-School-Year (EoS) Break Activities.
2. Schools Division Offices and/or schools cannot mandate and/or force teachers to participate to the NLC and other EoS Break Activities as directed by the following policies:
DepEd Order No. 13, s. 2023 (Adoption of the National Learning Recovery Program in the Department of Education)
Chapter IV, item 8.a: *"The NLC is a **voluntary End-of-School-Year (EoS) break program** designed to...enhance teacher capacity."*
DepEd Order No. 14, s. 2023 (Policy Guidelines on the Implementation of the National Learning Camp)
Item 3: *"This policy outlines the guidelines for implementing the **NLC, a voluntary learning recovery program**."*
Chapter III, item 7.e: *"**Remedial Class is a voluntary learning program for learners**...required for a particular learning area."*
Regional Memorandum No. 0663, s. 2023 (Learning is Fun at the Camp: The Implementation of the National Learning Camp in DepEd-Caraga)
Item 5: *"A letter of intent shall be submitted by teachers who will **volunteer** in the NLC and Other EoS Break Activities."*
