**CALL FOR SUBMISSION OF ENTRY NOMINEES FOR GAWAD LIYAB 2024
OUTSTANDING LITERACY PROGRAM AND LOCAL GOVERNMENT UNITS**

1. Pursuant to DepEd Memorandum No. 030, s. 2024 titled **"2024 National Literacy Awards (NLA),"** the Department of Education, through the Literacy Coordinating Council (LCC), shall conduct the 2024 National Literacy Awards (NLA).
2. The National Literacy Awards aim to recognize best literacy practices carried out by the Local Government Units (LGUs) and Non- government Organizations (NGOs). These practices should help alleviate poverty, provide livelihood, address welfare needs, promote freedom, and make education facilities accessible to all concerned sectors of society.
3. In this regard, the DepEd Caraga Region, through the Curriculum and Learning Management Division (CLMD) and the Regional Selection Committee, will facilitate the regional selection of entries for the different categories as listed below:

5. The NLA Regional Selection Committee will conduct the regional evaluation of documents of all entries on July 29, 2024. The onsite regional validation of the winning entries will be on July 30-31, 2024. Winners in each category will be endorsed by the Regional Selection Committee to the national level on August 1, 2024.
