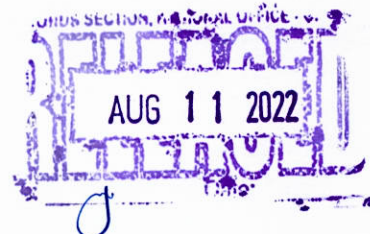

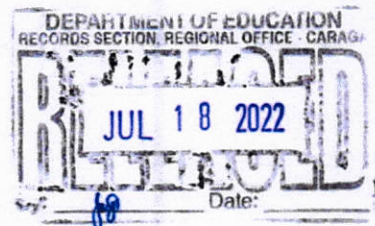

**PRESENTATION ON THE LOCALIZED DCP MONITORING SYSTEM CUM
COORDINATION MEETING ON ICTS PROGRAMS AND PROJECTS**

1. The ICT Unit of DepEd Caraga Regional Office will conduct a presentation on the localized DepEd Computerization Program (DCP) Monitoring System cum Coordination meeting with ITOs on ICTS programs and projects on July 21-22, 2022 at Grand Palace Hotel, Butuan City. Participants to this activity are the ICT Unit personnel in the regional office, Division ITOs, and SDO personnel who will assist ITOs in the DCP monitoring (preferably School ICT Coordinator).
2. The objectives of this activity include:
