REVIEW ON THE LITERACY REMEDIATION PROGRAM (LRP) LEARNING
RESOURCES FOR PHASE 2 TRAINING FOR REMEDIATION
TEACHERS AND SCHOOL LEADERS

1. The Post-test of the Literacy Remediation Program (LRP) has revealed a critical concern: 49 out of 1,954 Grade 3 learners continue to perform at a low emerging level in foundational literacy, even after participating in a summer remediation program.

2. In response, the region will conduct a Phase 2 Regional Training for Remediation Teachers and School Leaders, specifically targeting Grade 3 teachers and school leaders who have not yet undergone the LRP training. This training will focus on the implementation of the National Literacy Remediation Program, equipping teachers and school leaders with effective strategies, tools, and pedagogical approaches to meet the diverse literacy needs of learners.

3. Moreover, the results of the LRP underscore the need to critically review the learning resources used during the summer remediation program. The success of future interventions hinges on ensuring these materials are accurate, developmentally appropriate, and aligned with the ARAL framework's literacy goals. A thorough evaluation of these resources will help refine instructional content, improve learner engagement, and enhance the overall effectiveness of remediation efforts.
