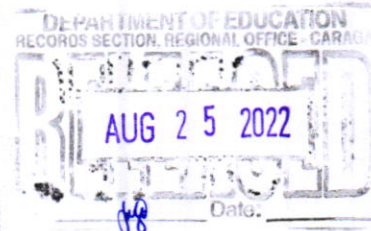

**SPECIAL VIRTUAL MEETING TO ADDRESS THE ISSUES AND CONCERNS
OF THE REVISED GUIDELINES ON THE ESTABLISHMENT, MERGING,
CONVERSION, AND NAMING/RENAMING OF PUBLIC SCHOOLS,
AND SEPARATION OF PUBLIC SCHOOL ANNEXES IN
BASIC EDUCATION, RE: DO NO. 40, S. 2014**

1. The Department of Education (DepEd) Caraga, through the Quality Assurance Division (QAD), shall conduct a **Special Virtual Meeting on August 26, 2022, at 10:00 o'clock** in the morning with **Atty. Alberto T. Escobarte**, Regional Director, DepEd Region 4A, along with **Atty. Rhoan L. Orebias**, Director IV, Legal Service Strand and **Ms. Sorayda Rangiris**, Head of Sites Titling Service, Legal Affairs Service Strand of DepEd Central Office, in order to shed lights on the issues and concerns raised during the re-orientation seminar on the Establishment, Merging, Conversion, and Naming/Renaming of Public Schools, and Separation of Public School Annexes in Basic Education, re: DO No. 40, s. 2014 conducted last June 8-9, 2022, at Balanghai Hotel and Convention, Butuan City.

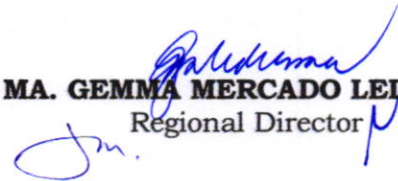
