DISSEMINATION OF DEPED MEMORANDUM NO. 072, s. 2022 IMPLEMENTING
MEMORANDUM CIRCULAR NO. 3, S. 2022 (Amending and Supplementing
Memorandum Circular No. 1, s. 2022 by Extending the Term of Office of
Government Officials and Employees Covered Therein and Fixing the
Rules Therefor, and Prohibiting New Contracts and
Disbursements of Extraordinary Funds)

1. DepEd Memorandum No. 072 s. of 2022 provides an extended period for all Officer In-Charge (OICs), non-Career Executive Service (CES) officials occupying CES positions, and contractual or casual employees covered by MC 1, s. 2022 to continue to perform their duties and discharge their functions until December 31, 2022, or until a replacement has been appointed or designated, whichever comes first. It was further reiterated in the said memorandum the submission of bi-monthly performance reports through their respective Regional Directors for submission to DepEd Central Office through the BHROD-PD of which this Office has not received such reports as of this date.

2. Item No. 4 of Memorandum Circular No. 3 also provides that;

*"Except for those involved in the food, transportation and energy sectors, or except when authorized by the President in meritorious cases, **the following shall not enter into new contracts or projects or disburse extraordinary funds:***

a. OICs of departments, offices, agencies, instrumentalities and bureaus covered therein;

b. GOCCs, government instrumentalities with corporate powers, government corporate entities, and government financial institutions, until such time that a new set of appointive directors have been appointed and chief executive officers elected in accordance with their respective charters, articles of

incorporation and by-laws in relation to Republic Act 10149 of the GOCC Governance Act of 2011; and

- c. The free port and special economic zone authorities, until such time that new sets of appointive directors have been appointed and chief executive officers elected.”*

3. Schools Division Superintendents and Assistant Schools Division Superintendents who are covered by these issuances are reminded to comply on the submission of Performance reports and observance of the prohibitions as embodied therein.
