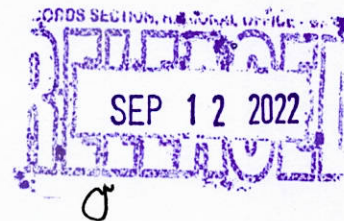

**ONSITE VALIDATION OF SENIOR HIGH SCHOOL TECHNICAL VOCATIONAL
LIVELIHOOD (SHS-TVL) TOOLS AND EQUIPMENT RE: QUANTITY,
SPECIFICATION AND PRICE DELIVERED BY JMKYLE TRADING**

1. The field is hereby informed that the Curriculum and Learning Management Division (CLMD) will conduct another round of onsite inspection of SHS-TVL tools and equipment on September 14-16, 2022 at the Schools Division of Agusan del Sur.
2. This onsite inspection, as recommended by the Accounting Unit of the Finance Division (FD), aims to determine the quantity, specification, price, and delivery information of the SHS-TVL tools and equipment delivered by the JMKYLE Trading.
3. The inspection team, composed of CLMD personnel and technical working group (TWG) from SDO-Agusan del Sur, and the schedule of the inspection are found in Enclosure A.
4. All School Heads of the concerned schools are directed to prepare the following documents: (1) Delivery Receipt (DR); (2) Inspection and Assessment Receipt (IAR); and the (3) corresponding SHS-TVL tools and equipment delivered by the JMKYLE Trading. The said documents will be verified by the inspection team. The inspection team will use the monitoring tool found in Enclosure B. Schools are no longer required to prefill the said monitoring tool.
5. The conduct of this inspection must not disrupt classes per DepEd Order No. 34, s. 2022. Thus, no teacher must be pulled out from his/her classes for the purpose of this inspection.
6. Traveling expenses and per diem of the inspection team shall be charged against CLMD MOOE funds subject to the usual government accounting rules and regulations.
