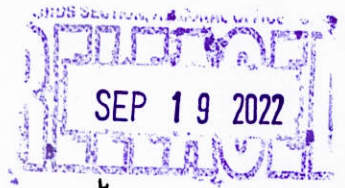

The Bureau of Alternative Education (BAE) will conduct the **18th National Consultative Conference** for Regional ALS Focal Persons and select Division ALS Focal Persons on **October 3-7, 2022** (inclusive of travel time) in **Astoria Hotel, Puerto Princesa City, Palawan**.

The said activity aims to:

- share the highlights of the implementation of ALS in SBM of select schools of SY 2020-2021
- discuss and gather inputs on the ALS M&E System Start-Up Process and Implementation Plan
- provide regional updates on ALS- related activities and deliverables
- present updates on BAE's activities and deliverables.

In view of this, the Regional ALS Focal Persons and two (2) select Division ALS Focal Persons (please see Attachment 1) are expected to participate in the abovementioned activity. The Regional ALS Focal Persons shall prepare for presentations listed in Attachment 2.

Further, **Ms. Jean S. Lasquite**, Regional ALS Focal Person of Region IV-B, is requested to assign at least two (2) documenters during the conference. They are expected to submit the minutes of the meeting to the BAE on October 21, 2022.

Transportation, board and lodging, and other expenses relative to the conduct of the activity shall be charged against the FY 2022 ALS Current Funds. Travel expenses of participants shall be reimbursed through the fund to be downloaded to their respective regions subject to the usual government accounting and auditing rules

and regulations. Should the downloaded fund intended for this purpose is insufficient to cover the actual, additional and other allowable expenses, the excess amount will be charged against the local funds or the Program Support Funds (PSF) for Fiscal Year (FY) 2022.

All participants are required to comply with all the guidelines for COVID-19 Alert Level System set by the national and local Inter-Agency Task Force for the Management of Emerging and Infectious Diseases (IATF), as well as the most recent DepEd rules and/or policies.

First meal to be served is dinner on October 3, 2022, and the last meal is lunch on October 7, 2022. Please see Attachment 3 (Indicative Program of Activities) for your reference.
