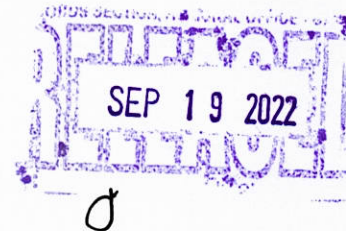

This Office, through the Bureau of Alternative Education (BAE), in partnership with the United Nations Children's Fund (UNICEF) - Philippines, through the University of Melbourne and the Assessment Curriculum and Technology Research Centre (ACTRC) conducted a feasibility study on ALS Micro-Certification in four Schools Division Offices. The result of the study demonstrates the potential of micro-certificates as valid, reliable, trusted, and valued credentials for learning attainment.

With the positive result of the said study, the BAE and UNICEF-Philippines drafted Policy Guidelines on the Implementation of Micro-Certification in the Alternative Learning System Programs.
