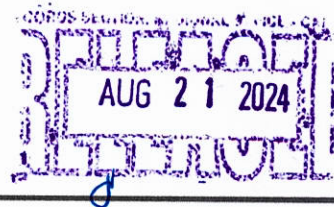

**CORRIGENDUM TO THE REGIONAL MEMORANDUM NO. 0792, S. 2024 TITLED:
ANNOUNCEMENT OF THE CONDUCT OF THE GAWAD TEODORA (GTA) 2024**

1. With reference to DepEd Memorandum No. 043, s. 2024, titled: Conduct of the Gawad Teodora Alonso (GTA) 2024 (6th National Competition Storybook Writing), the field is hereby informed that the submission of Category 1- Story Manuscripts for Grades 4, 5, and 6 shall be postponed until **August 20, 2024, midnight**.
2. Submission of the story manuscript entries shall be in PDF format and duly signed and accomplished scanned entry forms shall be done online by sending them to this email address: caragalr@deped.gov.ph. The hard copy of the duly accomplished and signed entry forms shall also be submitted to the region through courier on or before the end of August 2024.
3. Participating Schools Division Offices (SDOs) are reminded to submit the first three winners in their division competition. They also have to make sure that there are no identifying elements of the place (such as: name of school, barangay, any famous landmark or person, and the like), that is included or mentioned in the story and which will allude to the provenance of the entry. Presence of the latter, shall disqualify the entry.
4. Those SDOs that have already submitted prior to the postponement, shall also resubmit the same through email.
5. All other items and stipulations in RM 0792, s. 2024 are still enforced.

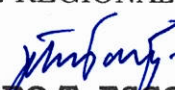
