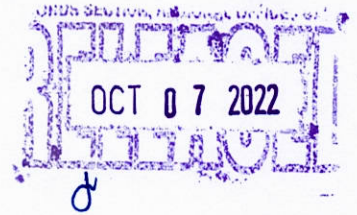

**ANNOUNCEMENT ON THE ISSUANCES OF GOVERNMENT RECOGNITIONS/
PERMITS TO OPERATE/CERTIFICATES OF COMPLIANCE
TO PRIVATE SCHOOLS SY 2022-2023**

1. The field is hereby informed on the issuances of Government Permits to Operate (GPTO)/Government Recognitions (GR)/Certificates of Compliance to private schools for SY 2022-2023 in the Divisions of Agusan del Sur and Butuan City.
2. Private school principal/administrator is advised to display the aforementioned GPTO for new establishment or renewal/GR/Certificate of Compliance Permit in a conspicuous place of the school.
3. The Government Permit to Operate which is temporary in nature shall be renewed on or before August 30 of every year preceding the start of the school year when the school/new course is supposed to operate or offer. On the other hand, Government Recognition Certificates for each year level or course shall be for an indefinite period provided that the requirements of law, rules and standard will be satisfied as stated D.O. No. 88, s. 2010, Section 29-30.

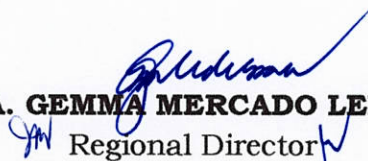
