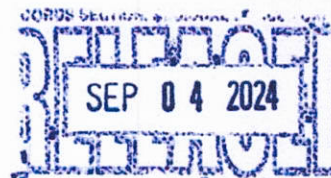

**CALL FOR SUBMISSION OF ENTRIES FOR THE 2024 GAWAD MATATAG:
OUTSTANDING ALS COMMUNITY LEARNING CENTER CATEGORY**

1. The Department of Education, through the Literacy Coordinating Council (LCC) and in line with DepEd Memorandum No. 30, s. 2024, is pleased to announce the **2024 Gawad MATATAG** to recognize outstanding Alternative Learning System (ALS) Community Learning Centers (CLCs) for their exceptional efforts and contributions to the improvement of learning outcomes among out-of-school youths and adults.
2. In this regard, the Regional Office is calling for the submission of entries from qualified ALS CLCs across the region. This award aims to honor ALS CLCs that have demonstrated excellence in the delivery of alternative learning and have significantly contributed to the education and empowerment of learners.
3. To qualify for the Gawad MATATAG, the ALS Community Learning Center (CLC) must be duly recognized by the DepEd and have been operational for at least the minimum number of years specified in the guidelines. The CLC should have a consistent track record of implementing innovative and effective educational programs tailored to the diverse needs of its learners. Also, the CLC must show active engagement in community partnerships and resource mobilization efforts that have yielded significant positive impacts on both the learners and the broader community.
4. The DepEd Caraga Region, through the Curriculum and Learning Management Division (CLMD) and the Regional Selection Committee, will evaluate all entry documents based on the established criteria and guidelines on September 19, 2024. The onsite regional validation of the winning entry will take place on September 20, 2024. The top entry will be endorsed by the Regional Selection Committee and forwarded to the National Level on September 21, 2024.
5. The acceptance of entries, including one (1) hard copy and a soft copy on a USB, is required on or before September 18, 2024. Submissions should be directed to the Curriculum and Learning Management Division (CLMD) through the Regional ALS Focal Person/NLA Regional Coordinator at josephinechonie.obsenares@deped.gov.ph, Attention: Bernabe L. Linog, Chief, CLMD.
