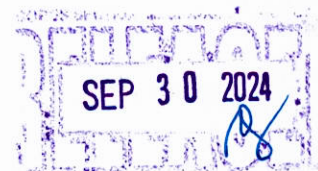

**ORIENTATION ON SAFE SPACES ACT CUM ORIENTATION ON THE
IMPLEMENTATION OF THE TEACHING MANUAL FOR CHILDREN'S
RIGHTS AND TRAINING OF TRAINERS FOR THE UTILIZATION
OF POSITIVE DISCIPLINE LEARNING ACTION CELL (LAC)
SESSION GUIDES IN THE FIELD**

1. This office, through the Education Support Services Division – Learner Rights and Protection Program, will conduct an *Orientation on Safe Spaces Act cum Orientation on the Implementation of the Teaching Manual for Children's Rights to be held on October 7-8, 2024 and Training of Trainers for the Utilization of Positive Discipline Learning Action Cell (LAC) Session Guides in Field* on October 9-10, 2024 within Butuan City.

2. The objectives of this activity are to disseminate and orient the Child Protection Policy, and enable the DepEd personnel to address gender-related violence, abuse, exploitation, discrimination, and bullying, as well as promote gender equality and non-discrimination within the DepEd workplace. Additionally, the activity aims to equip teachers, Registered Guidance Counselors, LRP focal persons, and LRP advocates with the skills to teach children about human rights through the Teaching Manual. The training will also assist the participants in constructing new knowledge about classroom management, specifically in revising traditional beliefs on corporal punishment, and incorporating the principles of positive discipline in alignment with relevant rules and regulations.

3. Participants in this activity are the following: Schools Division Offices (SDO) Learner Rights and Protection Focal Persons and their Alternates, 1 Registered Guidance Counselor and/or Designate, 1 Division Project Development Officer, and 1 School Head from each division.

4. Travel expenses shall be charged against the local funds, subject to existing accounting and auditing rules and regulations, as well as the internal policies of the Department of Education.
