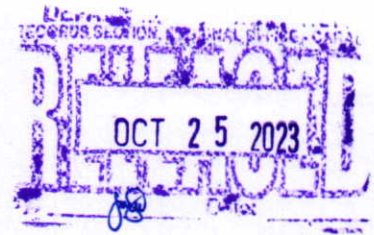

MULTIGRADE PROGRAM CUM STRATEGIC PLAN

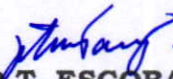
