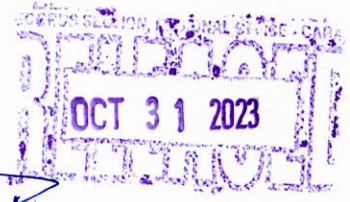

This refers to the implementation of the Joint Delivery Voucher Program for Senior High School Technical Vocational Livelihood Specializations (JDVP-SHS TVL).

For **CARAGA Administrative Region**, there are **4,408** JDVP learner-beneficiaries for the School Year 2022-2023.

As of **October 24, 2023**, the Government Assistance and Subsidies Office (GASO) successfully received billing statements for **2,108 (47.82%)** learner-beneficiaries. However, we have yet to receive billing statements for the remaining **2,300** learner-beneficiaries, constituting a significant **52.18%** of the total learner-beneficiaries

This situation necessitates immediate action. We would like to follow up for the submission of the JDVP billing documents until **November 17, 2023**, along with the vital data on the Assessment Result for SY 2022-2023.
